The regular meeting of the Monroe-Gregg Board of School Trustees began with the Pledge of Allegiance.

CALL TO ORDER

The meeting was called to order by School Board President, Mr. Brock Sears, at 6:35 P.M. in the Administration Office. PUBLIC HEARING FOR BARGAINING

MGTA Representative, Mrs. Casey Honkomp, spoke on behalf of the teacher's union. Mrs. Honkomp stated the union is looking forward to bargaining with respect to teacher salaries and fringe benefits. There were no other public comments. The hearing closed at 6:44 P.M.

CONSIDERATION TO ISSUE OBLIGATORY BONDS

Mr. Luke Bruggeman with Stifel Financial conducted a presentation related to 2022 General Obligatory Bonds. Dr. Freeman asked the Board for permission to move forward with the bond process. Mr. Elliott made a motion to give Dr. Freeman permission to move forward with the process. Mrs. Clements seconded, and the motion carried 5-0.

CONSIDERATION OF MINUTES

The motion was made by Mr. Kennedy to approve the Executive Session and Regular Board Meeting Minutes of July 11, 2022. Mr. Pridemore seconded, and the motion carried 5-0.

CONSIDERATION OF CLAIMS

Mr. Kennedy made the motion to approve claims #6278 through #6400 as presented in the amount of \$3,331,616.23. Seconded by Mrs. Clements, the motion carried 5-0.

CONSIDERATION OF PERSONNEL RECOMMENDATIONS

Mr. Elliott made the motion to approve all personnel recommendations. The motion was seconded by Mr. Pridemore. The motion carried 5-0.

CONSIDERATION OF UPDATED CELL PHONE REIMBURSEMENT

Corporation Treasurer, Mrs. Kelly Dillon, submitted a list of employees who may receive the cell phone compensation of \$50 per month. Mrs. Clements made a motion to approve the \$50 per month reimbursement as recommended. The motion was seconded by Mr. Kennedy and carried 5-0.
